### **POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 28 JUNE 2024**

The Board is pleased to announce that all the resolutions proposed at the AGM were duly passed by the Shareholders by way of poll.

Reference is made to the circular (the “**Circular**”) of JLogo Holdings Limited (the “**Company**”) and the notice (the “**Notice**”) of the annual general meeting (the “**AGM**”) dated 6 June 2024. #### **RESULTS OF THE AGM**

At the AGM held on 28 June 2024, all proposed resolutions as set out in the Notice were taken by poll. The Company’s branch share registrar in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
